



## **Code of conduct FISEC Games (for adults and participants, to be discussed with parents)**

### Introduction

Participation in the FISEC Games is not automatic in many of the countries participating in the Games. You have had to show an achievement as a team or as an individual to be selected. In other countries there is no selection, but you must have reached a high level in your sport. Whatever the case, as a reward for your strong performance, you are going to represent your country and that is a privilege.

To make sure that participants are well-respected and valued guests, FISEC expects the following of every participant:

- commitment, character, and perseverance: everybody should be eager to prove that his or her selection for these Games was a correct choice.
- a healthy and sporting attitude: you were selected in the first place to perform well in your sport; relaxing and enjoying yourself are of course part of this but can never be the first priority.
- to actively advocate a sport that is clean and free of manipulation in accordance with the WADA World Anti-Doping Code.
- team spirit and sportsmanship: as a team or as an individual you want to give the best of yourself, but this is always within the boundaries of fair play.
- self-discipline and respect: for people, accommodation, and materials; if everybody sticks to the rules, if we show respect for the other participants and for our surroundings, only then can such Games provide additional value.

### Rules during the Games

To make sure that such a large-scale event goes well, it is necessary to set up a code of conduct of which the basis is agreed .

- We expect fair play and honesty at all times.
- We expect respect towards other participants during matches, so no booing or cheering when the opponent fails or makes a mistake.
- You show respect towards the organising committee, also during official activities.

- Respectful behaviour also concerns modern means of communication such as mobile phones, computers, cameras, computernetworks, tablets etc.
- Any abuse to hurt, insult, intimidate or provoke others, will be considered a serious fact and will be punished severely.
- It is important to turn up at the right place at the right time  
You always have to ask your coach/supervisor for permission to leave the group
- You respect everybody's sleep, so no noise between 23.00 and 6.30 and nobody leaves his or her room during that period of time.
- Make sure your room is cleared up at all times
- In principle the rooms are only accessible for roommates, so not for other participants, certainly not when the occupants are not there themselves. If you want to arrange to meet someone, do so somewhere else.
- Please take care of your valuables, passport, money etc. FISEC advises you to keep them under lock and key and not leave them unguarded
- Smoking as well as the possession and use of alcohol, drugs and other forbidden substances are forbidden. If possession of, dealing in and/or use of any of these substances is detected, the Executive Bureau decides on the sanction which could be exclusion from further participation.
